### Report from the Treasurer for the Boscombe and Pokesdown

Below I summarize the statement I made at the AGM in 2019. Thank you to all who attended and hopefully this report will answer any questions for members and future members who were unable to attend.

In my role as Treasurer it is my role to maintain the bank account. All elected officers give their time and effort on a voluntarily basis. However for this project to be successfully implemented there will be certain costs involved mainly being that of a planning consultant. We have already employed the services of an experienced and local planning consultant, selected by the steering committee after going out for tender. Funding mainly comes in the form of grants, more of which later.

For clarity I will bullet point the financial activities to date:

- A business account was opened in 2016 with TSB on Boscombe High Street
- The account is specific for clubs, societies and charities and as such we will benefit from free banking.
- There will be no overdraft facility
- For the reasons of transparency and security a minimum of two signatories is required for any outgoing transaction
- Signatories are officers elected by the members and must include the Treasurer these are conditions written into the constitution
- All signatories are required to have a credit check and be respected members of the BAP community.
- We have received grants on total of £46,044.70 in total
- An Income and Expenditure forecast for the creation of the plan has been created by the planning consultant which details the anticipated costs (including her own)

At this stage there is no need to provide a balance sheet statement or profit and loss statement which would normally be in accordance with GAAP (generally accepted accounting principles). We have no fixed assets, neither tangible nor intangible and no current assets unless you want to consider cash reserves to be such. We are a not for profit organisation, the officers merely represent the members, who are all associated either by residency or business ownership within the community.
